

2019 Motorcycle Rules & Eligibility

The Union County Agricultural Society is a 501c(3) organization who proudly provides a vehicle for farmers young and old to showcase their finest products for 173 years.

- 1.) **ELIGIBILITY** Each entrant, by entering the Raffle, agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations, and further agrees to release the Union County Agricultural Society, Union County Fair and its directors, officers, agents, etc. from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. The Raffle is open to any eligible person residing in a country or state where the raffle is not prohibited. Entrants must be 18 years of age or older. Employees, Directors, (or their immediate family which would include spouses and children) of the Union County Agricultural Society are not eligible to enter.
- 2.) **RAFFLE TICKETS** The cost to purchase a single entry ticket for the Raffle is \$50.00 (U.S. funds only) and is not tax-deductible. Any entrant may purchase more than one ticket. An entrant can enter the Raffle by purchasing a ticket by calling 937-644-8736, or emailing UCFairRaffle@gmail.com, or in person during office hours located at 845 N. Main St., Marysville, OH 43040, or in person via a director of the Union County Agricultural Society, or in person at No Cages Harley-Davidson located at 7610 Commerce Pl, Plain City, OH 43064 during normal business hours. Payment can be made by VISA, MasterCard, Discover Card, or cash. If an entrant's payment is dishonored by the bank for any reason, such entrant's ticket will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Completed entry ticket forms and money must be in the possession of the Union County Agricultural Society by 11pm on THURSDAY, JULY 4, 2019. All ticket forms will be handled and recorded on a first come, first served basis. Any ticket forms and payments (including payments previously dishonored) received after closure of the Raffle will be returned to the entrant.
- 3.) **GRAND PRIZE** The Grand Prize is a 2018 Harley-Davidson Breakout. The Grand Prize winner must pick up the motorcycle at No Cages Harley-Davidson, 7610 Commerce Pl, Plain City, OH 43064. The winner is responsible for paying tax, title, freight, and doc fees as well as for all local, state, and general taxes which may be applicable. Cannot be redeemed for cash value. The winner is responsible for making any and all such arrangements with No Cages Harley-Davidson. The Union County Agricultural Society will not act as an agent on behalf of the winner.
- 4.) **2ND PRIZE** The 2nd Prize is an interior stateroom for two, including port charges and pre-paid gratuities, on the 2020 Buckeye Cruise for Cancer. Flights and transportation to and from port are not included. Cannot be redeemed for cash value.
- 5.) **WINNING CHANCES** A maximum of 500 Tickets will be sold. Each Ticket represents one chance to win. You may enter as many times as you like. Chances of winning a prize depend on the number of eligible Tickets sold. For the Grand Prize, if 500 Tickets are sold, your chance of winning the Grand Prize is 1 in 500.
- 6.) **DRAWINGS** Winner will be determined by random drawings of all the eligible Tickets received by the entry deadline. Winner need not be present to win. Drawing will be held at No Cages Harley-Davidson at 6pm on July 8, 2019. Prizes will be presented to the winners during the concert at the Union County Fair on Wednesday, July 24th. Winners will receive 2 passes each for

fair and concert admission. All applicable taxes and fees pertaining to the motorcycle must be paid before winner can take possession.

- 7.) **WINNERS** Winners will be notified by phone. Names of winners will be available on the Union County Fair social media outlets. Winning entrants agree to allow the Union County Agricultural Society to use their photos, names, likeness and statements made by them regarding the prize for advertising or publicity purposes without compensation. All applicable taxes and fees pertaining to the motorcycle must be paid before winner can take possession.
- 8.) **AUTHORITY AND CONTROL** The decision of the Union County Agricultural Society shall be final in all matters concerning the Raffle. The Raffle is subject to the laws of the State of Ohio. Void where prohibited by law.
